

**MINUTES
REGULAR MEETING
OF THE
MARBLE ROCK CITY COUNCIL
DECEMBER 6, 1999 7:30 P.M.**

The Regular Meeting of the Marble Rock City Council was called to order with Mayor Rohwedder presiding with Councilpersons Ackley, Engelhardt, Tweed present. Councilman Kingery arrived at 7:35 p.m. Also present were Liz Tegtmeier, Irven Tegtmeier, Kenny Fisher.

Moved Ackley/seconded Engelhardt to move from the regular agenda order to accommodate the guests. Roll: Ayes- All. Absent- Kingery. Carried.

Council was questioned why Mr. Rohwedder had not paid the rent on the street rental yet. Councilman Ackley stated that the lease was not completed and that as soon as complete, it would be signed and the rent would be paid.
